A participating school campus is granted a site license for public broadcast specific to the school name indicated on page one of this form. All CDs or digital files remain the physical and intellectual property of The Character Network and are not the property of the school campus indicated on page one of this form because this membership does not represent the purchase of any physical or intellectual material, only the site license for public broadcast and only for the duration stated on page one. Any physical electronic media must be returned after the last day of the stated school year and received by The Character Network prior to the first day of the following school year if the school chooses not to renew its membership for the following school year. The school indicated on page one is responsible for return shipping costs.

Copyright laws prohibit public use of these programs after the last day of school in the stated school year without a renewed school-year-specific membership\*. A new school-year-specific set of CDs or other physical electronic media will be distributed (after receipt of a membership renewal) at or shortly before the beginning of each new school year. A new membership, however, may start at any time during a school year for schools that do not currently have a membership.
