A participating school campus is granted a site license for public broadcast specific to the school name indicated on Page One of this form. All CDs or other electronic physical media remain the physical and intellectual property of The Character Network and are not the property of any school campus because this sponsorship does not represent the purchase of any physical or intellectual material, only the site license for public broadcast and only for the duration stated on Page One. The CDs or other electronic physical media must be returned after the last day of the stated school year and received by The Character Network prior to the first day of the following school year if the school chooses not to renew membership for the following school year. The school indicated on Page One is responsible for return shipping costs. Copyright laws prohibit public use of these programs after the last day of school in the stated school year without a new membership*. A new school-year-specific set of CDs or other electronic physical media or download will be distributed (after receipt of a new membership agreement) at or shortly before the beginning of each new school year.
